## CONTRACT AGREEMENT

THIS AGREEMENT made the 11<sup>th</sup> day of September, 2017 between UNIVERSITY OF GHANA (hereinafter called "the Purchaser") of the one part and DCL LABORATORY PRODUCTS LIMITED of ACCRA, GHANA (hereinafter called "the Supplier") of the other part:

The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such O ther sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the Contract
