Happy new year to you and your team. Kindly find attached comments for the EMP for the WACCI building. We have provided some specific comments within the text but we also have the following general comments;

- We will require an executive summary of the EMP which should include a checklist to enable easy tracking and supervision of the proposed mitigation measures.
- In addition kindly ensure that the summary table is detailed enough, capturing all proposed mitigation measures
- The analysis of the identified impacts as either significant or otherwise considering the duration and type is missing.
- The section on workplace safety should be further strengthened with clear responsibilities for provision and enforcement of the use of PPEs during construction and operational phases of the project
- We notice that there is no budget for the implementation of the EMP, if this is already part of the works contract this should be stated clearly.
- The document is difficult to read and understand in some sections and we strongly recommend a spell and grammatical check as well as word formatting before resubmission. Additional comments have been provided within the text for guidance.

Once these comments are addressed we can review and clear the EMP.
